The Karuk Tribe requests proposals for the following Scope of Work required for the demolition and removal of existing old, unsafe and underrated electrical wiring, boxes and panel(s) to be replaced with all new wiring and equipment to suit current power needs and proper electrical builders code, in the facility known as the Log Cabin, located 533 Jacobs Way in Happy Camp, CA.

**Task One – Demolition**

The demolition of existing old, unsafe and underrated electrical wiring, boxes/panel(s) including service and related equipment. All electrical debris will be removed and properly disposed of by the contractor.

**Task Two – Installation of primary wiring**

Supply and install new electrical wiring using MC cabling and metallic EMT conduits (or owner approved equivalent) suitable for commercial buildings following the owner request about locations for receptacle light fixtures and electrical service.

**Task Three – Installation of associated electrical parts**

Supply and install electrical panel(s), light switches, dimmers, occupancy sensors, receptacles, fixtures. Supply and install electrical safety disconnects whenever required. Grounding and bonding of all electrical components to be installed to local electrical building code minimums.

**Responses to this Request for Proposals should include the following:**

- 1) A statement of qualifications, including relevant project history.
- 2) A proposed approach and rationale for completion of the contract tasks described above, including descriptions of similar work previously completed and the results/benefits achieved.
- 3) A lump sum price, with attached price break-down page.
- 4) Names and telephone numbers of three client references.
